**We invite artists to submit works for our March 2018 O'Hanlon Gallery exhibit "Music as Muse."**

*How does music inform your art?*

*Do you listen to music when you create?*

*How do the rhythms and patterns in your ears translate to your hands and into a visual form?*

Works submitted for this exhibit may either involve Music as part of the subject matter, or may be works that were inspired by a specific musical selection or musical artist, group, etc. Sculptural and 3D pieces are welcome! When dropping off your artwork, you'll have a chance to write-up a brief note (optional) about what music is connected to your piece, which may be seen by the Jurors.

*Contemporary, expressionistic, abstract, exploratory, and/or experimental entries encouraged.*

*O'Hanlon Center for the Arts emphasizes the creative process and the continued pursuit of meaning and authenticity through observation, exploration, and experimentation.*

### MEDIA: All Media

- Open to all artists age 16 and over.
- Submission limit: 3 works per artist.
- Please do not submit works previously displayed in the O'Hanlon Gallery.

### ART PREPARATION

- **All work** must be **ready for display**.
- **Wall hung pieces** must be **securely wired**.
- **Label all work** with **Artist's name, Telephone, Medium, Size & Price**, if for sale.
- Bring **resume** and/or **artist statement**, if desired. (2 pages max.)

**About the Jurors: Donna Seager & Paul Liberatore**

A native of New Orleans, **Donna Seager** began in the art business in 1978. She was the director of Marlborough Gallery in Boston before moving to California in 1989. She continued to work in galleries in the bay area until 2005 when she opened her own gallery.

Seager has distinguished herself for her discerning eye and commitment to the arts in her community. She has given lectures on the art of the book at international fairs in Miami and San Francisco. In six years, the gallery became a destination for artists and collectors all over the bay area.

Liberatore is also the author of “*The Road to Hell: The True Story of George Jackson, Stephen Bingham and the San Quentin Massacre,*” a New York Times “Book of the Times.” He will continue to write a biweekly column on the music and entertainment scene for the Marin IJ.
